1. **Introduction:**

Welcome to Royl Photography, a professional real estate, architecture, and interior design photography company based in College Station, TX. By engaging our services, you agree to be bound by the following terms and conditions.

2. **Scope of Services:**

Royl Photography provides professional photography services for real estate listings, architectural projects, and interior design portfolios. Our services may include photography, aerial photography, videography, virtual tours, and any additional services as agreed upon with the client.

3. **Booking and Scheduling:**

Clients must book photography sessions in advance by contacting Royl Photography via phone, email, or through our online booking system. Sessions are scheduled based on availability and are subject to confirmation by Royl Photography.

4. **Payment and Fees:**

Payment for photography services is due at the time of booking unless otherwise agreed upon. Royl Photography reserves the right to charge additional fees for services such as travel outside of our standard service area, rush orders, or specialized equipment requirements.

5. **Cancellation and Rescheduling:**

Clients may cancel or reschedule photography sessions up to 48 hours before the scheduled appointment without incurring any fees. Cancellations made

within 48 hours of the scheduled appointment may be subject to a cancellation fee.

6. **Property Preparation:**

It is the responsibility of the client to ensure that the property is clean, decluttered, and properly staged prior to the photography session. Failure to adequately prepare the property may result in suboptimal photographs and may require additional fees for reshoots.

7. **Copyright and Usage Rights:**

All visual content created by Royl Photography is protected by copyright law. Upon full payment for services rendered, clients are granted a exclusive, perpetual license to use the visual content for marketing and promotional purposes related to the sale or rental of the property depicted in the content. If additional out-side 3rd parties would like to use the visual content created during the shoot, they are required to contact ROYL PHOTOGRAPHY DIRECTLY. Violations to use of such content created will result in additional fines and fees. Such fines and fees are required to pay restitution in to Royl Photography no later then 5 days to avoid additional late Penalties.
